The Bureau of Indian Standards (BIS) is a government body under the Ministry of Consumer Affairs, responsible for setting quality and safety standards for products circulating in the Indian market. Through its official website, BIS provides access to Indian Standards (IS) for various products, identified by unique IS numbers.

BIS registration ensures that products meet these standards, promoting safety, quality, and consumer trust.

BIS Registration For Aluminium Products-

Ministry of Mines issued 3 Quality Control Order's (QCO) in the year 2023 mandating BIS Registration on 27 types of Aluminium Products such as Ingots, Billets, Extrusions, Sheets, Utensils, Cans etc. The said products will be covered under Scheme - I of BIS i.e. ISI Mark scheme. After the date of implementation, manufacturing and selling of Non - Complied Aluminium products will be illegal.
